## German Cockroach Treatment Prep Sheet

Prior to your Technician's Arrival:

Please review & complete all the necessary preparations listed below. These steps will ensure that your Technician is able to provide best effective and safe treatment.

## **Preparation Process**

### General

- Clear all countertops
- Remove all items from kitchen cabinets from both top and bottom
- Clear all Bathroom cabinets from top and bottom
- Pull out refrigerator 2 feet away from the wall
- Pull out stove 2 feet away from the wall
- Remove all outlet plate covers



- No food should be exposed in any areas. Keep garbage and food to a minimum and throw out your garbage daily. Ensure dirty dishes are not left out overnight.
- Access to all plumbing lines under sinks is required; please have all items in the cupboard below the sink cleared out.

#### Pets

Birds and Pets must be removed from the premises for 4 hours.

#### Important Reminder

- You will need to vacate the Area.
- It is necessary for you or your pets to be out of your home during the treatment and to stay out for 4 hours after the treatment.

Upon Re-entry open the windows for 20 minutes to properly ventilate the treated room

After Treatment the products applied will only be effective if the following steps are taken after your home is serviced:

- DO NOT use other pest control chemicals (powders or sprays) or cleaning products near areas that have been sprayed, as this will decrease or eliminate the effectiveness of the treatments.
- Upon re-entry to your home, do not wash any of the baseboards for a period of at least
  2 weeks. The pesticide residual effects lessen by washing.
- You may notice more cockroaches after a treatment. Roaches will become disoriented, wander, and die soon after treatment.
- The California Department of Pesticide Regulation (CDPR) and the Structural Pest Control Board (SPCB) enforce state laws and regulations pertaining to pesticide use, sales, licensing, worker protection safety. All companies and workers must meet state regulations to conduct business within the structural pest control board. All chemicals purchased and used in the state of California must be regulated by CDPR and SPCB

### Please note the following important information:

- ☐ If you cancel your appointment less than 24 hours before your scheduled service, a \$50 cancellation fee will be charged. To avoid a cancellation fee please make sure you cancel or reschedule your service 24 hours before in advance.
- Our German roach spray treatment includes a 30-day guarantee.
- ☐ In the event this prep sheet is not followed thoroughly and it is determined by the technician that the required preparations necessary for treatment were not appropriately completed, the 30-day guarantee will be voided.
